1. On June 16, 2010, at 1:30 p.m. in the BOULDER County Court, 1777 6th Street, P.O. Box 4249, Boulder, CO 80302, if an answer is not filed, the court may be asked to enter judgment against you as set forth in the complaint.
2. A copy of the complaint against you and an answer form which you must use if you file an answer are attached.
3. If you do not agree with the complaint, then you must either:
 - a. Go to the court, located at 1777 6th Street, P.O. Box 4249, Boulder, CO 80302, at the above date and time and file the answer stating any legal reason you have why judgment should not be entered against you, or
 - b. File the answer with the court before that date and time.
4. When you file your answer, you must pay a filing fee to the Clerk of the Court.
5. If you file an answer, you must give or mail a copy to the Plaintiff or the attorney who signed the complaint.
6. If you do not file an answer, then the court may enter a default judgment against you for the relief requested in the complaint.
7. If you want a jury trial, you must ask for one in the answer and pay a jury fee in addition to the filing fee.
8. If you want to file an answer or request a jury trial and you are indigent, you must appear at the above date and time, fill out a financial affidavit, and ask the court to waive the fee.

COMPLAINT UNDER SIMPLIFIED CIVIL PROCEDURE	

Plaintiff Credit Acceptance Corporation ("Credit Acceptance Corporation"), by its attorneys, Silverman Law Firm, P.C., for its Complaint against TODD BURKE, ("Defendant") states and alleges as follows:

GENERAL ALLEGATIONS

1. Credit Acceptance Corporation is a financial institution authorized to do business in the State of Colorado.
2. TODD BURKE is an individual believed to be residing in the County of BOULDER, Colorado with an address of 1895 ALPINE AVE APT F19, BOULDER CO 80304.
3. Venue is proper in this county pursuant to Colorado Rules of County Court Civil Procedure Rule 398(c), as Defendant's principal place of residence is in BOULDER County, Colorado.
4. The amount claimed herein does not exceed the jurisdiction of the court.
5. Based on reasonable inquiry, Defendant is not an infant or incompetent or an officer or agency of the State of Colorado or in the military service of the United States.
6. Credit Acceptance Corporation is the holder of a Retail Installment Contract dated September 12, 2005, in the original amount of \$17,488.80, (the "Contract") executed by Defendant. A copy of the Contract is attached hereto and incorporated herein by reference as Exhibit 1.
7. The Contract was secured by a 1999 FORD EXPEDITION, VIN# 1FMPU18L9XLC41423 ("Vehicle").
8. The Vehicle was repossessed and sold by Credit Acceptance Corporation leaving a deficiency amount still due.
9. The Defendant has failed to pay the payments due under the Contract.

10. The Vehicle was repossessed and sold by Credit Acceptance Corporation through an auction, in a commercially reasonable fashion, in a manner consistent with the sale of repossessed vehicles in all other Credit Acceptance Corporation transactions, leaving a deficiency amount still due.
11. Credit Acceptance Corporation has satisfied all conditions precedent to the bringing of this action.
12. Credit Acceptance Corporation has, at all times, done and performed all of the stipulations, terms and conditions stated in said Contract to be performed on its part at the time and in the manner therein specified.
13. Defendant is liable to Credit Acceptance Corporation in the principal amount of \$3,242.78, or according to proof, plus interest as of the date of this Complaint, in the amount of \$128.74, with interest accruing thereafter at the rate of 21% per annum.
14. Pursuant to the Contract, Defendant is also liable for costs, expenses and reasonable attorney's fees incurred by Credit Acceptance Corporation .

WHEREFORE, PLAINTIFF Credit Acceptance Corporation requests an Order from this Court for entry of judgment in its favor and against TODD BURKE : (a) for all amounts due under the Contract, including, without limitation, principal, pre-judgment and post judgment interest, costs, expenses and reasonable attorneys' fees; (b) for such further relief as this Court deems just and proper.
