Dear Mr. Ingham:

I have already reported to you on the gist of the October 20th debtor exam for Todd Burke and Kim Gleason. Mr. Gleason has not had contact with Mr. Burke for about two years and has not done his taxes or those of his companies in longer than that. He brought some old mail and gave that to Mr. Burke. He did not have anything else to say. Mr. Burke says that he now has Kim Gleason off all the current corporate records with the Colorado Secretary of State and that Mr. Gleason has no relationship to him now.

Mr. Burke explained the corporate structure of his business world. Aspen Beyond, Inc. does business as True Aspen, Inc. True Aspen is not a separate company as are all the other businesses tied to a particular destination city. The other corporate entities are as follows: Telluride Beach LLC is his company that does website design, marketing, and the business cards and literature for his business entities. Telluride LLC, True South Africa LLC, True Cabo LLC, True Nantucket LLC, True Costa Rica LLC, True Hawaii LLC, True Norcal, LLC (Marin County), and True Tahoe LLC are all current entities which have lodging and activities lined up. Todd is hoping these get off the ground. He has lodging and local guide arrangements. Clients pay an initial membership fee of \$50,000 and an annual membership fee of \$2500.00 plus pay for the individual vacations at a rate of \$2000 to \$25,000 per night. High end clients. True Key LLC is the managing company that collects these fees and then distributes them to the LLC's. Client's pay the vacation charges directly to the local destination LLC. Todd says he wants to cap membership at 150 families.

Aspen Beyond Inc. is the parent company and owns 51 percent of the South Africa, Nantucket, Tahoe, Telluride, Norcal, Costa Rica, and Hawaii destination LLC's. Misi Hara Corporation owns the other 49 percent. That company helped with funding. Aspen Beyond Inc. owns 100 percent of True Cabo LLC.

Todd owns 75 percent of Aspen Beyond Inc. Julie Uranga owns 15 percent, Keith Hardigan owns 5 percent, and Pat Howe owns 5 percent.

Todd is divorced and now lives at 1303 Alpine Avenue #14, Boulder, CO 80303. He pays \$1750 per month rent. He has a 14 year old son who lives with his mother at 1895 Alpine Avenue, Boulder, CO 80304. He has the son about half the time. Todd has almost no money in his American National Bank and Great Western Bank accounts. The IRS has a lien on the American National Bank account so that account is dormant at \$1.00. He leases a 2006 Range Rover. He is selling shares in Aspen Beyond Inc. to persons who will lend him money for living expenses. He has not filed federal income tax returns for two years, but is working on that. He will send me copies when he files those. He hopes that his concept will be a wild success or possibly once the companies are profitable, he will sell them in the next couple of years.

At the conclusion of the debtor exam, I left it that we would keep in touch every three months to see what payments he can begin to make. So I will be contacting him in January and then in April. Hopefully the companies will be making money to enable Todd to take draws to begin paying this judgment. Todd does not have other debt. You were the only cell phone tower investor to sue him. Everyone else just let their investments go and did not sue.

So I will be in touch with you in January with an update.

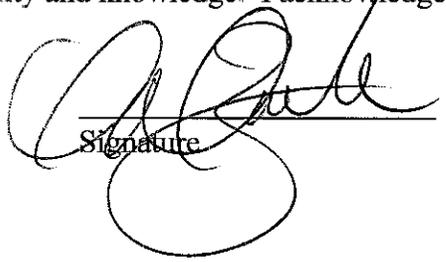
